Kansas State has expanded eligibility for its Land Grant Promise to students from all 105 Kansas counties. The K-State Land Grant Promise assures that full-time, Pell-eligible undergraduates with a total household income of \$70,000 or less will receive a total grant and scholarship aid package up to the equivalent cost of 15 credit hours of in-state tuition.

Students are automatically evaluated for this opportunity once they are enrolled at full time and have completed the Free Application for Federal Student Aid, or FAFSA, by K-State's priority date of March 1. The promise, which has been expanded to all K-State locations — including the Manhattan, Salina and Olathe campuses and K-State Online — is offered to qualifying undergraduates actively working toward their first bachelor's degrees.

The Elks offer a national scholarship program dubbed "Most Valuable Student." Over 500 scholarships will be awarded, ranging from \$4000 to \$30,000. Apply by November 13 at [enf.elks.org/MVS](http://enf.elks.org/MVS).

Local Elks lodges also offer a Legacy Scholarship for college bound seniors who are children or grandchildren of Elks Members. Applications are available at [enf.elks.org/leg](http://enf.elks.org/leg). These are due at the local lodge by February 5.

If you are applying for the Legacy Scholarship to the Hoxie Lodge just submit name/DOB/Parents Name; a brief description of plans after high school; a copy of senior transcript; a list of school and community activities; and one letter of recommendation. Wichita State offers scholarships of up to \$64,000. But you must have completed the application process to WSU by October 15 to be eligible for these competitive scholarships.
