You still have time to enroll for Spring at Colby Community College. It is now offering a Certificate of Completion for High School students in Solar PV and Wind Technology. This unique two-semester program specifically concentrates on Solar Photovoltaic (PV) and Wind Technology. Solar PV and Wind is one of the fastest growing technologies in the energy market. Because this program is online, it gives the student the ability to learn and work from anywhere with internet access.

This program can be taken as a full-time, part time, or even a high school student. High School students can take courses for dual credit (if their school supports this program). If a high school is located in Kansas, Senate Bill 155 applies (funds the student's tuition). Students can also start this program in the fall or spring semester (every 8-weeks) Each 8-weeks, the student will participate in an online course or courses that will precisely prepare him/her for a career in Solar PV and/or Wind Technology.
