- The WKLL has decided to not hold our high school league basketball tournament in Colby this next year. The Event Center will not make a commitment to allow the league to hold specific days under contract for the tournament. The league voted to hold the quarterfinals and semifinal games this next year in Grinnell and Grainfield, with all Saturday games being held at Trego Community High School in Wakeeney.
- 2. The Middle and High School Track teams competed in their league track meets this past Friday in Hill City. The Middle School girls took second place by 1 point and the Middle School boys took 7th overall. On the High School side, the high school girls took first and the boys took 3rd. The high school teams will travel to Tribune this Friday to compete in the Regional Track Meet.
- At our last league meeting, our Commissioner reported that by 2025, the shot clock in basketball will make its way into Kansas High Schools. This will come at an additional cost of \$2000-3000 to each district.
- 4. I would like to start some additional fundraising efforts for the athletic department. This year is the first time since I have been AD that we have gone in the red. Lack of attendance at home games, rise in the cost of entry fees, and rising official fees have caused the loss of revenue. Ideas:
 - a. Sell sponsorship banners to businesses around the local area for \$300 for first year and \$100 each year after that. They would be hung up out at the football field and basketball gym during those respective seasons
 - b. Sell game sponsorships for each home contest. Ask the businesses if they would want to cover the cost of admission or the cost of officials fees for the evening. In return they would get two home passes for

the next school year.

- 5. Starting this year, all team sports have a chance to compete in one jamboree scrimmage prior to the start of their first regular season game. This gives the teams a chance to have some outside competition prior to their first regular season game, and to also help give some referring experience to younger officials just getting started.
- 6. Coaches and sponsors in our district were asked to fill out a SWOT (Strengths, Weaknesses, Opportunities and Threats) assessment of our activities and athletic programs. I wanted to get an idea of what they felt about our programs. Below are the responses:

Committed and caring coaches/sponsors

Summer programs (weights & individual sport opportunities)

Opportunities for competition (full schedules)

What do you believe are the 3 greatest weaknesses of our activities /athletic department?

With small numbers it is hard to get some student competition experience

Some coach/sponsor burnout due to sponsoring/coaching multiple activities

Funding to support the amount of excess time coaches and sponsors put in to helping students succeed

The decline in participation numbers in activities especially on the girl's side of athletics Same small group of students participate and are involved in everything. Could possibly get burned out

Our younger students believe that if they can't start on varsity then they don't feel like they matter.

I feel that our activities/athletic department doesn't have any major weaknesses except for the one listed below: Lack of JV opportunities for sub varsity players (due to lack of numbers from both our and our opponents)

Community support, enthusiasm from home fans, students looking forward to the next season and not finishing the job at hand

Limited number of participants

Facilities – no track and no second competition gym

What do you believe are the 3 greatest opportunities of our activities/athletic department?

Tradition and the want to continue to be successful

Possibilities of adding or removing activities as student interest changes

Continue to have high expectations of students both in the classroom and in their activities

A great opportunity for all students to get involved in a wide variety of activities (Band, vocal, FFA, Scholars Bowl, etc...)

MOST coaches promote the ideas the ALL sports and activities are important. Students should be involved in many activities

Sponsors and coaches are willing to work with one another in helping each other's activities

All students have an opportunity to participate in any and all activities/athletic programs Ability of our coaching staff to have the ability to work one-on-one with specific players Ability to build lasting relationships with our players/participants

Music has the potential to be unique in 1A, sports has a great tradition, forensics/scholars bow all have had success in post season

All those things combined give GP students the opportunity to excel and be involved Number of activities for a school our size

All students are allowed to participate without pay to play

What do you believe are the 3 greatest threats of our activities/athletic department?

Burnout by some kids doing too much and not keeping up or feeling overwhelmed Too much pressure to remain successful

Lack of funding to keep sponsors/coaches and to purchase materials needed The last few teaching hires have been made without regard to helping fill coaching and sponsorship positions

Over involvement of some parents in our district. They don't allow coaches and sponsors to do their job

Decline in support of our activities by the community. (Lack of crowds at regional volleyball and several home basketball games this year for example). When support goes so does our activities and eventually our school.

The main threat that I see for our activities/athletic department is the lack of desire of students to participate in anything that our school has to offer

Students are more interested in getting a job instead of being kid and enjoying high school activities

Job schedules of students, apathy from students, lack of support and enthusiasm for ALL activities

 school year of \$16,631 for '23-'24 school year.

- Establish the Special Education and Related Services Funding Task Force.
- Amend the Kansas School Equity and Enhancement Act (KSEEA) with regard to the calculation of State Foundational Aid and modifying the low enrollment and high enrollment weightings.
- Extend the sunset for the high-density, at-risk weighting.
- Extend the 20-mill exemption for two years.
